

TERMS AND CONDITIONS OF THE REQUEST FOR PROPOSAL TO BIDDERS

1. **Background.** Army Public School, Ahmednagar intending proposal for Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar.
2. It is in this context that the proposal has been invited for Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar.
3. **Scope of Work.**
 - (a) The scope of work/ specification includes Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar.
 - (b) The required technical specifications for Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar is as per **Annexure-III**
4. Bidder shall be responsible for turn-key delivery of the assignment of Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar as per the requirement.
5. **Site of Delivery & Construction.** The site of delivery of Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab is Senior Wing, APS Ahmednagar. (Maharashtra).
6. Based on the network of operations & capabilities, the interested eligible bidders to submit their proposals to Army Public School, Ahmednagar. The Bidders should carefully draft their technical & financial proposals in accordance.
7. **Qualification Criteria.** The Bidder must fulfill the following eligibility conditions :-
 - (a) Bidder must be a reputed / authorized firm/ auth dealer of VR eqpts / services.
 - (b) Bidders firm should have at least **5 years' experience** in reputed service / authorized firm/ auth dealer of VR equipments / services (provide certification for this).
 - (c) The Bidder must have PAN Number / Tax Identification Number (TIN) and should have all the necessary registrations under GST, VAT, CST, Service Tax, Sales Tax / Excise Duty, IEC number etc. (**Enclose the Documents**).
 - (d) Bidders should be capable of ensuring timely and safe delivery of replacement, Supply, Delivery & installation of chain-link fencing at Primary Wing, Army Public School, Ahmednagar at proposed site in the school (enclose self-attested certificate for confirmation).
8. **Mode of Bid Submission.** Proposals shall be sent through registered post or professional courier service so as to reach the school address on or before the due date. Alternatively, the proposals can also be submitted in person by authorized representative of the Bidder.
9. The proposals (**each page**) **must be duly signed by authorized signatory of the Bidder with firm stamp and date.** Corrections made in the offer shall be authenticated by the signature of the authorized signatory of the bidder with firm stamp.

10. A pre-bid meeting for bidders will be held one week before the opening of the tender.
11. The Bidder shall submit the **Technical** proposal and **Financial** proposal in original. Proposals must be submitted not later than 04 July 2024 to the following address :-

12. The Technical proposal shall be placed in a sealed envelope marked "**Technical Proposal – Envelope A**". In the technical proposal, there should not be any indication about the prices of any of the products offered. Financial proposal shall be placed in a sealed envelope clearly marked "**Financial Proposal - Envelope B**". The two envelopes containing the technical and financial proposals shall be placed & sealed into an outer envelope super scribed "**Est of VR Lab**". This outer envelope shall bear the submission address. Army Public School, Ahmednagar will not be responsible for misplacement, loss, and delay during transit of the bid documents.
13. The Bidders shall structure the proposals in the format as prescribed.
14. Any further clarifications or details be needed, the interested bidders shall communicate in writing to the focal person of Army Public School, Ahmednagar within 07 days of issue of tender. The bidder should send the queries / clarifications through official E-mail IDs only.
15. Proposals received after due date or unsealed or unsigned or incomplete will be rejected.
16. **Earnest Money Deposit.** The technical bid shall be accompanied by an amount of **Rs 5,000/-** (Rupees Five Thousand Only) in form of a **Demand Draft** drawn in favors of Army Public School, Ahmednagar as Earnest Money Deposit (**EMD**).
17. The EMD of the successful bidder shall be retained by **Army Public School, Ahmednagar** as a performance security till the completion of the assignment. The EMD of the unsuccessful bids shall be refunded.
18. If the successful Bidder fail to act according to the tender conditions or backs out after the tender has been accepted, the EMD will be forfeited.
19. **Technical Proposal.** The technical proposal should comprise of following: -
- (a) Proposal submission form / statement of declaration duly filled, signed and complete in all respects be submitted as per **Annexure – I**.
- (b) Bidder information form duly filled, signed and complete in all respects is submitted as per **Annexure – II** for establishing the eligibility and qualifications of the Bidder.
- (c) Bidders shall submit the illustrated pamphlets / brochures containing all the technical details, specification of the tendered items. Specifications such as make and other distinguishing marks with respect to the standard/quality of the item(s) wherever necessary should be indicated in the proposal.
20. Self-attested copy of PAN, general as well as central/ State Sales Tax Registration Certificates/ VAT Registration Certificate/ GST Certificate, any other relevant certificates.

20. An undertaking regarding Warranty/ Guarantee/ Free service being offered by the Bidder should be submitted as per **Annexure – IV** attached.
21. All documents shall be enclosed in a cover super scribed as '**Technical Bid – Envelope A**'.
22. **Financial Proposal.** Financial Proposal should comprise of the following :-
 - (a) Financial Proposal Submission Form duly filled, signed and complete in all respects (**Annexure – V**) separately.
 - (b) The financial proposal should be quoted in Indian Rupees (INR) for "**Est of VR Lab**".
23. The Bidder shall carefully split the financial proposal in accordance to include all charges including basic price, applicable taxes and duties, packing and forwarding charges including estimated loading/unloading, plantation /growing of grass & commissioning charges etc.
24. Discount, if any, should be merged with the quoted price of **Annexure – V** separately.
25. The rates quoted should be firm and not be subjected to any price variation clause.
26. Financial Proposal to be enclosed in a separate cover super scribed as '**Financial Proposal – Envelope B**'.
27. **Bid Validity.** The quotation should be kept valid for a minimum period of **three months** from the last date of the bid submission as prescribed in the tender document.
28. **Evaluation.** An evaluation committee constituted by APS, Ahmednagar and AC Centre & School will evaluate the proposals. Evaluation Committee will examine the bids to determine whether they are complete, whether any computational errors have been made, and whether the bids are generally in order. The committee may conduct clarification meetings with each bidder to discuss any matters, technical or otherwise.
29. As pre-qualification criteria, the documents will be examined to determine whether the bidder meets the eligibility criteria, completeness of the bid, whether the documents have been properly signed and whether the bids are generally in order. Any bids found to be non-responsive for any reason or not meeting the minimum levels of the performance or eligibility criteria specified in the various sections of this RFP will be rejected and not included for further consideration.
30. A detailed evaluation of the bids shall be carried out in order to determine whether the bidders are competent enough and whether the technical aspects are substantially responsive to the requirements set forth in RFP.
31. Quoting merely the lowest price does not confer any right to any bidder for award of supply order/ work order. The Evaluation Committee reserves the right to select any bid under the grounds of specification compliance, usage suitability, design, economic suitability, brand value, proven Track record and reputation in supplies to Government organizations.
32. **Delivery Terms.** Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar. Transport to the destination shall be arranged and paid for by the bidder.

34. The suppliers should ensure that he himself or his authorized representative is available for proper handing over Supply, Delivery, installation and establishment of VR (Virtual Reality) Lab at Senior Wing, APS Ahmednagar. Successful Bidder shall ensure timely completion of project as would be stipulated in the work order.

35. **Penalty.** In the event of failure of the successful Bidder to make the supply of the items/Wk ordered within the stipulated time, without prejudice to other remedies under the supply order a penalty equivalent to 1% of the value of delayed goods will be levied per week with a maximum of 10% of the contract value. However, relaxations would be entertained only in special circumstances.

36. **Performance Guarantee.** Successful Bidder shall be required to deposit 5% of the value of contract to Tenderer/Purchaser as performance security in form of Bank Guarantee with in week of issue of work order by Army Public School, Ahmednagar and would to be maintained for six months after completion of work.

37. **Tenderer Reserves the Following Rights.** To accept any bid and to reject any or all bids at any time prior to issue supply order without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the reasons or grounds for Tenderer's / Purchaser's action, to relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the overall programme without assigning any reasons thereof. The school management remains rights to change in Specification/ Design/ Location/ Material/ Colour/Item etc. at any stage of project.

38. **Penalty for substandard wk.** After completion of proj, if PMG noticed that material supplied/ used, work executed by the vendor of substandard, then penalty will be decided by the school management and will be maximum of 25%

39. **Subletting of Contract.** Once supply/ work order awarded to the supplier/contractor, the contract will not be further sublet in any circumstances and same will not be accepted.


40. **Rejection of Proposal.** The application will be summarily rejected if :-
